BOARDWALK REIT ANNOUNCES JANUARY MONTHLY DISTRIBUTION

Calgary, Alberta – January 15, 2009 – Boardwalk Real Estate Investment Trust (“**BEL.UN**” – TSX) has declared its January 2009 distribution in the amount of 15.00 cents per Trust unit. The distribution will be payable on February 16, 2009 to Unitholders of Record on January 30, 2009.

Boardwalk REIT is Canada’s largest owner/operator of multi-family rental communities. Boardwalk REIT currently owns and operates in excess of 260 properties with 36,785 rental units totaling approximately 31 million net rentable square feet. The Trust’s portfolio is concentrated in the provinces of Alberta, British Columbia, Saskatchewan, Ontario and Quebec. Boardwalk REIT’s Trust units are listed on the Toronto Stock Exchange, trading under the symbol BEL.UN. The Trust’s total Enterprise Value is over \$3.0 billion.
